EDUCATIONAL LOAN SCHEME RULES

- 1. The assistance under EDUCATION LOAN SCHEME will be given to Kutchhi Visha Oswal students.
- 2. The loan will be given for higher studies in India or abroad or as decided by Shri K.V.O. Seva Samaj from time to time.
- 3. The application form has to be completed in all respect. Incomplete application, furnishing falls information and hiding of any information will be liable for rejection of application. Shri K.V.O. Seva Samaj reserves the right to disburse the loan amount in full, part or reject the application without giving any reasons. The application will be rejected if student obtains marks less than decided level and/or for poor performance.
- The student and his/her earning parents/guardian have to sign the application form and/or the loan agreement will be responsible for timely repayment of the loan.
- If the loan is not used for the specified purpose, Shri K.V.O. Seva Samaj will have rights to call back the loan amount alongwith the interest thereof at the rate of 18% per annum.
- The applicant has to submit the application along-with two KVO guarantors in the enclosed form. One guarantor should be from his village in Kutch and other from a business man/professional field of specialisation.
- Applicant has to enclose following documents along with his application: Copy of Ration Card, Copy of Last Exam Pass
 Certificate/Mark Sheet, One passport size photograph, Copy of College/Coaching Classes fee receipt/Copy of Income
 Tax Returns (Last two years), Admission Letter/I-20 letter Copy of Passport and Visa (last three items for students going
 abroad).
- 8. Repayment of the loan schedule will be as under: During the study time a token amount will have to be paid amount upto Rs. 1000/- on quarterly basis. On completion of study loan instalments will be rescheduled depending upon total loan amount outstanding, Rescheduled loan instalment will have to be paid after completion of study or generation of income which ever is earlier.
- If the applicant or his/her parents/guardian are unable to repay the loan, the guarantors will have to repay the loan together with interest, jointly or separately.
- 10. If the loan repayment is not made in time or as per schedule or the loan is used for the purpose other than education, then Shri K.V.O. Seva Samaj will have right to acquire and sell the property belonging to the applicant or his family and/or his parents/guarantors to the extent of loan amount and other expenditure incurred if any, with interest at the rate of 18% per annum.
- Any change in material information supplied in this application, change in address, telephone numbers of applicant or guarantor has to be intimated to Shri K.V.O. Seva Samaj immediately.
- The applicant will insure himself at least to the extent of loan amount and pledge the policy in favour of Seva Samaj till
 the loan is fully repaid.
- 13. The student should communicate the progress/results of his educational exams every year. Failure to furnish results will result in cancellation of loan and action will be initiated to call for the loan.
- 14. The students going abroad with assistantship should start repaying loan within six months of reaching abroad.
- 15. The student proceeding abroad without getting assistantship should initimate the Seva Samaj as soon as the assistantship is confirmed. In such cases loan repayment will start within six months of receipt of assistantship.
- 16. In case the student, taking the loan, is unable to complete his education or drops out of college then he should inform Seva Samaj. He should repay entire loan within 30 days of his dropping out. The conditions enumerated at item nos. 5, 9 and 10 of Rules regarding interest rate and recovery from guarantor will apply in this case.
- 17. Shri K.V.O. Seva Samaj reserves right to change above rules and the same will be binding to applicant/lonee.
